


# Technical Data



## AMBERKLENE ME20 HEAVY DUTY SOLVENT



**AMBERKLENE ME20** is a powerful solvent blend which contains **no CFCs or other chlorinated solvent**. It is an ideal alternative to 1,1,1 Trichloroethane.

### APPLICATIONS

A highly effective degreasing agent, controlled evaporation allows increased contact time for excellent performance on heavy deposits of oil, grease and tar. Also effective on many other types of soiling. For all hydrocarbon soiling, for use in numerous industries including:
