Surface Preparation

Surfaces should be swept free of loose material and must be completely dry.

Scotchkote Clear Waterproofing WP880 is a single component material supplied ready for use.

Application

Do not apply when the relative humidity exceeds 85% or when the surface to be coated is less than 3°C (36°F) above the dew point. The minimum temperature for application is 7°C (45°F).

Scotchkote Clear Waterproofing WP880 can be applied by brush or spray and should be liberally applied on to the surface at a nominal wet film thickness of 90 microns (3½ mils) per coat, with a minimum of two coats being required for most masonry surfaces.

All equipment must be cleaned IMMEDIATELY after use with clean water. Any stubborn deposits should be removed with 3M™ Scotchkote™ Cleaner 020.
